The Offering

JLL's National Retail Investment Group and TD Securities (together, the "Advisors") have been retained by the Vendor on an exclusive basis to arrange the sale of Heritage Place, a 307,139 square foot enclosed mall situated on approximately 37.5 acres which includes additional land density, in Owen Sound, Ontario (collectively, the "Offering").

Heritage Place is the dominant centre in Grey and Bruce Counties and occupies a high profile position fronting on 16th Street East/Highway 26, the major east-west thoroughfare in the area.

Heritage Place opened its doors in 1987, an expansion was completed in 1989, and in 2017, the centre welcomed Giant Tiger, Urban Planet and a 24-hour GoodLife Fitness who now occupy the completely transformed former Zellers location. Anchored by Food Basics, Giant Tiger, GoodLife Fitness and Sport Chek, Heritage Place is the dominant retail centre within its vast trade area.

Positioned within the heart of Owen Sound's primary retail node, the centre benefits from high traffic counts along 16th Street East (approximately 16,000 vehicles per day) and captures a significant market share of the Grey and Bruce County consumer base, comprising over 100,000 residents.
