

**“Minnesota Wild – Sheboygan Sausage Wild Sweepstakes”  
Official Rules**

**1. ELIGIBILITY. Minnesota Wild – Sheboygan Sausage Wild Sweepstakes** (the “Sweepstakes”) is only open to entrants who, as of the entry date, are permanent legal residents of the States of Minnesota and who are at least eighteen (18) years old. The Sweepstakes is void outside the States of Minnesota, Wisconsin, North Dakota, South Dakota, Iowa and where prohibited or restricted by law. Full Time employees, officers and directors of American Foods Group, LLC. (“Sponsor”), the Minnesota Wild Hockey Club LP (“Wild”), and their respective parents, subsidiaries, affiliates, divisions, advertising and promotion agencies (Collectively, “Co-Sponsors”), and the immediate families (defined as parents, spouses, children, siblings, grandparents, and their respective spouses) or members of the same household (whether related or not) of each such employee, officer and director, are not eligible to enter. The Sweepstakes, and any website pages and advertisements relating thereto, is intended for viewing only within the eligible sweepstakes territory, and entrants must be present in the eligible sweepstakes territory at the time they enter.

**2. TIMING.** The Sweepstakes entry period begins at 12:01 a.m. Central Time (“CT”) on **January 1, 2023** and ends at 11:59 p.m. CT on **March 9, 2023** (the “Entry Period”). Sponsor’s computer is the official timekeeping device for the Sweepstakes.

**3. HOW TO ENTER. To enter the Sweepstakes:**

**a. **b. FOR ALL ENTRIES:** One entry per person in the Sweepstakes. All entries must be received by the Wild during the Entry Period (or during such certain dates and times within the Entry Period as expressly specified above). All entries become the exclusive property of the Wild and none will be acknowledged or returned. All entrants and entries subject to verification prior to the awarding of a prize, as are the eligibility, age and other claims of/information provided by a potential prize winner.

**4. AGREEMENT TO OFFICIAL RULES AND DECISIONS.** By participating in the Sweepstakes, each entrant fully and unconditionally agrees to be bound by and accepts these Official Rules and the decisions of the Co-Sponsors (including, without limitation, decisions regarding eligibility of entries, the selection of entrants and the winners, and the awarding of prizes), which are final and binding in all respects.

**5. DRAWING; ODDS; NOTIFICATION.** On or about **Wednesday March 9th**, the Wild will randomly select three (3) potential winners from among all eligible entries received by the Wild. Odds of winning the prize depend on the number of eligible entries received by Wild in the Sweepstakes. The entrants selected must comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. The potential winners will be notified either by telephone or e-mail using the contact information as provided in their entry form. The potential winners may be required to execute and return to Sponsor and/or Wild a notarized Affidavit of Eligibility, a Liability Release, and a Publicity Release (except where prohibited by law) (an “Affidavit/Release”) in the form(s) provided by Sponsor and/or Wild in order to claim his/her prize. The Affidavit/Release must be returned by the date and/or time indicated within the Affidavit/Release. If the potential winners cannot be contacted within two (2) days of the first attempt to contact him/her, or if the potential winners fails to return the Affidavit/Release within the specified time, or if any prize or prize notification is returned as undeliverable, or if the potential winners is found to be ineligible, then the potential winner may be disqualified and an alternate winner selected by Wild in his/her place from among all eligible non-winning entries received by Wild for the Sweepstakes. In such event, an alternate potential

Exact price and location of seats to be determined by Wild in its sole discretion with an approximate retail value (“ARV”) of \$1,200.00;

One (1) Second Place Prize will be awarded during the Entry Period in this Sweepstakes. The prize includes and is limited to one (1) player autographed Minnesota Wild jersey and Sheboygan Sausage Company merchandise with approximate retail value (“ARV”) of \$575.00;

Total ARV of all prizes: \$3,525.00 USD

All prizes must be accepted as awarded, and prize is awarded “AS IS” with no warranty, representation, or guarantee, express or implied, in fact or in law, made by Sweepstakes Entities or for which Sweepstakes Entities shall be liable, including, without limitation, ANY IMPLIED WARRANTIES OF MERCHANTABILITY, NON-INFRINGEMENT OR FITNESS FOR A PARTICULAR PURPOSE. No substitution, assignment, refund or transfer of a prize is permitted, except by Sweepstakes Entities, who reserve the right to substitute a prize (or a component thereof) with another prize (or component thereof) of greater or equal value, including cash, if a prize is not available for any reason as determined by a Sweepstakes Entity in its sole discretion. **8. GENERAL CONDITIONS.** The Co-Sponsors reserve the right, in their sole discretion, to terminate, modify or suspend the Sweepstakes if, in the Co-Sponsors’ opinion, there is any suspected or actual evidence of electronic or non-electronic tampering with any portion of the Sweepstakes, or if viruses, bugs, unauthorized intervention, fraud, technical difficulties or failures or any other factor beyond Co-Sponsors’ reasonable control corrupt or affect the administration, security, fairness, integrity or proper conduct of the Sweepstakes. In such event, the Co-Sponsors reserve the right (but do not have the obligation) in their sole discretion to award prizes at random from among eligible, non-suspect entries received up to the time of suspected impairment. The Co-Sponsors reserve the right in their sole discretion to disqualify any individual they find to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately damage any website or undermine the legitimate operation of this Sweepstakes is a violation of criminal and civil laws, and, should such an attempt be made, Co-Sponsors reserve the right to seek damages and other remedies from any such person to the fullest extent permitted by law. RELEASE.** By entering, each entrant forever and irrevocably releases and holds harmless Sponsor, the Wild, their respective parents, subsidiaries and affiliates, and their respective agents, advertising and promotion agencies, affiliates, Sweepstakes partners and prize suppliers, and all of their respective employees, officers, directors, shareholders and agents from and against all claims, damages or liabilities arising in whole or in part,

directly or indirectly, from entrant's participation and/or entry in the Sweepstakes and/or entrant's award, receipt or use of any prize awarded in the Sweepstakes.

**10. LIMITATIONS OF LIABILITY.** Neither Sponsor nor the Wild are responsible for: (a) incorrect or inaccurate transcription of entry information or late, lost, stolen, unintelligible, illegible, damaged, mutilated, altered, incomplete, misdirected or postage due entries or entries received through impermissible or illegitimate channels, all of which will be disqualified; (b) technical failures of any kind, including but not limited to the malfunctioning of any telephone, computer online systems, computer equipment, website, server provider, network, hardware or software; (c) the unavailability or inaccessibility of any website or service; (d) unauthorized intervention in any part of the entry process or the Sweepstakes; (e) printing, typographical, electronic or human errors which may occur in the offer or administration of the Sweepstakes or the processing of entries; or (f) any injury or damage to persons or property, including but not limited to entrant's computer, which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Sweepstakes, or from viewing, playing or downloading any material from Sponsor's or the Wild's website(s), regardless of whether the material was prepared by Sponsor, the Wild or a third party, and regardless of whether the material is connected to Sponsor's or the Wild's respective websites by a hypertext link.
